H&C. Concrete Sealer Clear Gloss is a silicone acrylic based waterproofing sealer, formulated for use on interior and exterior vertical and horizontal brick, stone, masonry, and epoxy-set chatahoochee stone.

For a complete waterproof system on very porous masonry surfaces(\*Splitface, CMU, Fluted block), apply 1 flood coat of H&C. HB-100 or HB-150 then 2 coats of H&C. Concrete Sealer Clear Gloss. Refer to the HB-100/150 data sheet for specific application instructions.

\*Lightweight Split Faced block may require a film forming product due to it's extreme porosity.

## SURFACE PREPARATION

**Testing**: Due to the wide variety of substrates, preparation methods, application methods and environments, the customer should test the product in an inconspicuous spot for adhesion and compatibility prior to full scale application. All surfaces must be clean, dry and free of grease, oil, paint, sealers, etc. To clean, use **H&C Cleaner Degreaser**, following label directions, rinse thoroughly and allow the surface to dry. If mold, mildew or fungus are present, kill and remove by cleaning with a solution of 1 part household bleach to 3 parts water.

#### Bare Concrete:

New concrete must be cured 28 days. All horizontal concrete must be etched with **H&C**® Etching Solution first, following label directions. For very smooth surfaces (troweled surfaces with no porosity) use **H&C**® Etching Solution at full strength. For smooth-troweled concrete with some porosity, 1 part H&C® Etching Solution to two parts water should be used. Do not etch painted surfaces. Prepared concrete should have a pH between 6 and 10.

#### Repair:

For the best waterproofing protection on vertical concrete and masonry, patch and repair cracks and crevices where water can enter. On floor surfaces, use appropriate patching material. Patching compounds will generally be visible through clear coatings.

## APPLICATION

Wait at least 24 hours after washing or after rain before applying. Apply under very dry conditions only. Application to a damp surface may cause a hazy appearance or loss of adhesion.
Air and surface temperature should be

between 50° and 90°F for 24 hours following application.

- Do not over apply
- Stir thoroughly before and during application.
- Do not reduce.

• Stir slowly, do not shake. Avoid whipping air into the sealer.

#### Slip Resistance

Some surfaces such as inclined driveways, garages, steps, patios, etc., may require a slip resistant additive for safety. Add **H&C**® **SharkGrip Slip Resistant Additive** to the final coat applied following label directions. This product should not be used in place of a non-skid finish.

## **CLEANUP INFORMATION**

Clean spills and spatters immediately with mineral spirits. Clean tools immediately after use with mineral spirits. Follow manufacturer's safety recommendations when using any solvent.
